Based on Article 16 of the Higher Education Act (Official Gazette of the Republic of Slovenia, No. 32/12 – official consolidated text, 40/12-ZUJF (Fiscal Balance Act) and 57/12-ZPCP-2D (Road Transport Act) and 109/12), Rules on the Register of Higher Education Institutions (Official Gazette of the Republic of Slovenia, No. 46/05) and the General Administrative Procedure Act (Official Gazette of the Republic of Slovenia, No. 24/06 – official consolidated text, 105/06-ZUS-1 (Administrative Dispute Act), 126/07, 65/08, 47/09, 8/10 and 82/13) the minister of education, science and sport, ex officio, issues the following

D E C I S I O N

1. The data on the reaccreditation of the 2nd cycle Master's study programmes "**Management and Quality Assurance in Education**" and "**Knowledge Management**" for seven years is entered into the register of higher education institutions, under the consecutive number 20, the **International School for Social and Business Studies**, Mariborska 7, Celje.
2. There were no costs incurred in this procedure.

E x p l a n a t i o n :

Based on Article 16 of the Higher Education Act, higher education institutions can start operating once they are entered into the register of higher education institutions, kept by the ministry responsible for higher education. In addition to other matters, the mentioned Article stipulates that the decision regarding reaccreditation of the higher education institution and of the study programme adopted by the Slovenian Quality Assurance Agency for Higher Education is entered into the register of higher education institutions.

In compliance with Article 51h, par. 11, item 7, of the Higher Education Act, the Council of the Slovenian Quality Assurance Agency for Higher Education (hereinafter referred to as SQAA Council) decides about the accreditation of study programmes and gives consent to changes in study programmes. Article 51.o, par. 3, of the Higher Education Act stipulates that the first accreditation and every reaccreditation of higher education institutions and of study programmes is valid for up to seven years. If the decision on the reaccreditation is adopted before the previous, the first or the renewed accreditation expires, the accreditation validity period starts anew. It applies that the accreditation validity expires at the end of the academic year, when the validity period of the granted accreditation expires. Article 51r, par. 5, of the Higher Education Act stipulates that, during the decision process regarding reaccreditation, one of the following decisions is adopted by the SQAA Council: reaccreditation of the higher education institution or of the study programme for the period of seven years, reaccreditation of the higher education institution or of the study programme for a shorter period of time, which may not be longer than three years, or the accreditation of the higher education institution or of the study programme is not renewed.

Article 8, par. 1, of the Rules on the Register of Higher Education Institutions (hereinafter referred to as Rules) stipulates that changes in the data are entered into the Register. Furthermore, Article 8, par. 3, of the Rules stipulates that, ex officio, also the data on the reaccreditation of the higher education institution and of the study programme is entered for all higher education institutions.

At its 71st meeting, held on 19 March 2013, the SQAA Council adopted the decision No. 6033-39/2013/8 dated 19 March 2013, on the basis of which it renewed the accreditation of the 2nd cycle Master's study programmes "Management and Quality of Education" and "Knowledge Management" of the International School for Social and Business Studies for seven years.

As a consequence of this, the data on reaccreditation of the Master's study programmes "Management and Quality in Education" and "Knowledge Management" of the International School for Social and Business Studies for seven years, i.e. till the end of the academic year of 2020/2021, is ex officio entered into the register of higher education institutions at the Ministry of Education, Science and Sport.

On the basis of Article 118 of the General Administrative Procedure Act, in the decision, the body decides on the costs of the procedure, who the costs are covered by, the amount of the costs and the due date. In this procedure, there were no costs.

According to the provisions of Article 28, item 1, of the Administrative Fees Act (Official Gazette of the Republic of Slovenia, No. 106/10 – official consolidated text), this decision is exempt from fee.

Legal Instruction: No appeal against this decision in accordance with regular administrative procedure is possible; administrative dispute is allowed, by lodging an action before the Administrative Court of the Republic of Slovenia, Fajfarjeva 33, 1000 Ljubljana, within thirty days after this decision is served. The action is lodged directly at the relevant court in writing or sent by mail. It applies that the action was lodged on the day when it was sent by registered mail.

O D L O Č B O

1. V razvid visokošolskih zavodov pri Ministrstvu za izobraževanje, znanost in šport, se pod zaporedno številko 20, **Mednarodna fakulteta za družbene in poslovne študije**, Mariborska cesta 7, Celje, vpiše podatek o podaljšanju akreditacije magistrskima študijskima programoma druge stopnje »**Vodenje in kakovost v izobraževanju**« in »**Management znanja**«, za sedem let.

2. Stroški v tem postopku niso nastali.

O b r a z l o ž i t e v :

Na podlagi 16. člena Zakona o visokem šolstvu (v nadaljevanju: ZViS) visokošolski zavod lahko začne opravljati svojo dejavnost, ko se vpiše v razvid visokošolskih zavodov, ki ga vodi ministrstvo, pristojno za visoko šolstvo. Predmetni člen med drugim določa tudi, da se v razvid visokošolskih zavodov vpiše odločitev Nacionalne agencije Republike Slovenije za kakovost v visokem šolstvu glede podaljšanja akreditacije visokošolskega zavoda in študijskega programa.

Skladno s sedmo alinejo enajstega odstavka 51.h člena ZViS svet Nacionalne agencije Republike Slovenije za kakovost v visokem šolstvu (v nadaljevanju: svet NAKVIS) odloča o akreditacijah študijskih programov in daje soglasje k spremembam študijskih programov. Tretji odstavek 51.o člena ZViS določa, da prva in vsaka podaljšana akreditacija visokošolskih zavodov in študijskih programov velja največ sedem let. Če se odločitev o podaljšanju akreditacije sprejme pred potekom roka, za katerega je bila podeljena prejšnja, prva ali podaljšana akreditacija, začne rok veljavnosti akreditacije teči znova. Šteje se, da veljavnost akreditacije poteče z zaključkom študijskega leta, v katerem se izteče obdobje podeljene akreditacije. Peti odstavek 51.r člena ZViS določa, da svet NAKVIS v postopku podaljšanja akreditacije sprejme eno izmed naslednjih odločitev: podaljša akreditacijo visokošolskega zavoda ali študijskega programa za obdobje sedem let, podaljša akreditacijo visokošolskega zavoda ali študijskega programa za krajše obdobje, ki ne sme biti daljše od treh let, ne podaljša akreditacije visokošolskega zavoda ali študijskega programa.

Prvi odstavek 8. člena Pravilnika o razvidu visokošolskih zavodov (v nadaljevanju: pravilnik) določa, da se v razvid vpisujejo spremembe podatkov. Nadalje tretji odstavek predmetnega

člena pravilnika določa, da se po uradni dolžnosti za vse visokošolske zavode vpišejo tudi podatki o ponovni akreditaciji visokošolskega zavoda in študijskega programa.

Svet NAKVIS je na svoji 71. seji, dne 19. 9. 2013, sprejel odločbo št. 6033-39/2013/8 z dne 19. 9. 2013, s katero je podaljšal akreditacijo magistrskima študijskima programoma druge stopnje »Vodenje in kakovost v izobraževanju« in »Management znanja« Mednarodne fakultete za družbene in poslovne študije, za sedem let.

Vsled navedenemu se v razvid visokošolskih zavodov pri Ministrstvu za izobraževanje, znanost in šport po uradni dolžnosti vpiše podatek o podaljšanju akreditacije magistrskima študijskima programoma druge stopnje »Vodenje in kakovost v izobraževanju« in »Management znanja« Mednarodne fakultete za družbene in poslovne študije, za sedem let, to je do zaključka študijskega leta 2020/2021.

Na podlagi 118. člena Zakona o splošnem upravnem postopku organ v odločbi odloči o stroških postopka, kdo trpi stroške postopka, koliko znašajo ter komu in v katerem roku jih je treba plačati. Stroški v tem postopku niso nastali.

Ta odločba je po določbah 1. točke 28. člena Zakona o upravnih taksa (Uradni list RS, št. 106/10 - uradno prečiščeno besedilo) takse prosta.

Pouk o pravnem sredstvu: Zoper to odločbo ni pritožbe po redni upravni poti, pač pa je dovoljen upravni spor z vložitvijo tožbe na Upravno sodišče RS, Fajfarjeva 33, 1000 Ljubljana, v tridesetih dneh od vročitve te odločbe. Tožba se vloži pri pristojnem sodišču neposredno pisno ali pa se mu pošlje po pošti. Šteje se, da je bila tožba vložena pri sodišču tisti dan, ko je bila priporočeno oddana na pošto.
